

are seen to have inspired youth who have been taken by the IS in its fold, and also the Dhaka case pertains to two alleged terrorists inspired by his speeches to join IS, we are concentrating on his videos relating to the same. In these speeches we are checking if he has spoken anything that could be construed as 'inspiring' youth to join IS," said a senior official.

While the last public address by Naik in Mumbai was in 2011, the police are unlikely to dwell on his previous speeches. "He has been giving speeches since 1995, it wouldn't be possible to dwell on all his speeches... Therefore, this inquiry will only concentrate on those speeches in which he advocated to the youth, or the Muslim community in general, to take up arms or join a terror outfit. Even if these speeches are before 2013 and if he is seen promoting a terror outfit or a terrorist, they will be analysed," added the official.

Meanwhile Naik, who cancelled a press conference scheduled for Tuesday, said he was the victim of a media trial. "Most of the clips shown on television of myself are either out of context, half statements or doctored. So are my statements in the print media," Naik alleged.

He said he would respond to allegations through videos on social media. "So far, not a single official Indian government agency has contacted me for any clarification... It would be my pleasure to cooperate with any official Indian government investigation agency for any information...," the statement read. A spokesperson for Islamic Research Foundation said that with the press meet cancelled, Naik would continue with his original itinerary.

Sena seeks arrest

Mumbai: The Shiv Sena has sought the arrest of Zakir Naik. "Zakir Naik is playing a divisive role for this country. He is presently outside the country. He should be arrested as soon as he lands on Indian soil," Shiv Sena said in an editorial in party mouthpiece *Saamana*.

TMC MP backs him

Kolkata: TMC MP Idris Ali Monday claimed that Naik does not support terrorism, leading his party to caution him. Ali said: "Whatever deliberations of Naik I have heard, I have not found any controversial element." **ENS**
